During the last weekend of May, the Board held a three-day face-to-face meeting at the Secretariat in Melbourne. Members will have seen in previous issues that the changes planned under the Board's strategy are now coming to reality and it was pleasing for the Board to be able to see for themselves the roll-out of exciting improvements in commu-

nications and learning opportunities.

The Board covered an extensive range of issues during the meeting; from hearing from the Advanced Practice Working Group through to more effective ways to engage students and PDY practitioners in the AIR. All of our panels are working hard on important issues, and the Board received comprehensive reports on matters requiring our attentions from OQAP, PAEB, MIAP1 and MIAP2 and RTAP as well as those mentioned above.

The Board has asked that future issues of *Spectrum* contain articles on all the developments which are taking place, as well as the AIR responses to the various and complex external issues.

We have prepared AIR position papers on National Registration due to be in place by mid 2012 for our profession – we support and welcome this initiative. We are particularly delighted to see that this will bring about registration of practitioners in New South Wales and South Australia.

We are receiving many enquiries about the introduction of practitioner assistants, and have placed on the AIR website a clear policy statement reflecting members' views that the issues is one of the delivery of ionizing radiation. The Board is working more on this issue and closely monitoring developments.
